Whilst I was working at Camps bay Law Enforcement station during the period of January and July 201 I noticed irregularities with the members of the Ndabeni training centre specifically Insp. Quanita Adams and LEO Bradley Faure where they were leaving their work station early and even playing horse races at the TOTE. LEO Faure even once got permission from Insp. DuPlesis to go to the TOTE to play horse races, on condition that he just takes off his epaulettes. Insp. Adams at some occasions left early whether she left to the training centre that I don't know but I know is that they were booked overtime at Camps bay. According to Insp. Marinus if we were booked to work overtime at a station we must remain in that specific area for the remainder of the work schedule.

Whilst working at Camps bay what I've noticed is that the members of the training centre never worked a full 8 hour shift. To me this was unacceptable because what goes for one must go for everyone. I want this matter to be investigated as this is serious allegations, and that I made this statement out of my own free will and were not influenced by anyone.

I asked the question several times to Insp. Marinus where Mr Abrahams has gone to, and he just answered and said no he went to book off Ndabeni training centre. Mr Abrahams never worked his full time and to me this amounts to fraud and also they as an inspector he should set an example. Sometimes Mr Abrahams came on duty took out his laptop worked for a couple of hours on the computer, and then he packed up his stuff and left from camps bay office never to returned.

Insp. Marinus always covered up for Mr Abrahams when he left early and never gave me right answer as to where Mr Abrahams has gone to whether his gone home or went to book off at Ndabeni training centre. As a concerned officer I am raising this matter and am well aware that this is serious allegations but am willing to give witness to this effect. The reason why I'm only reporting this matter now is the fact that I was scared of being victimised. Secondly I was still a temporary member and was yet to become permanent and was told by P/insp. Noordien and S/insp. Overmeyer that the Inspectors must give recommendation for me to become permanent. They also said that without that recommendation I will never become permanent and that they have the last say.
